## **Standing Rules for the Clubroom at Post 149**

Dated: February 15, 2022

- 1. Only the following persons shall be admitted to the clubroom
  - a. All members of the American Legion with current Membership Card.
  - **b.** Members (Sponsor) Guests are encouraged to sign the Clubroom Guest Book.
  - **c.** Post members are encouraged to welcome and sponsor as guests, current active military personnel, and Auxiliary, SAL, VFW and DAV members.
  - **d.** Members (Sponsors) are responsible for their quests and their conduct.
  - e. Guests may not remain in the Clubroom after their Sponsor departs.
  - f. Any Veteran with proof of military service and their guests.
- 2. Proper attire should be comfortable and respectful. Persons not wearing shoes or shirt will not be served and will be asked to leave the premises.
- 3. Members and guests are requested to help keep the Clubroom clean at all times.
- 4. The Clubroom manager or bartender on shift shall have full authority to enforce the Standing Rules and may refuse service to, and/or eject any member or guest for misconduct or violation of Clubroom Standing Rules. The Clubroom manager may also discipline members within the guidelines set forth in Post 149 Standing Rules C. 5. as needed.
- 5. Hours of operation will be set by the Board of Directors and posted.

NOTE: At the discretion of the bartender on shift, the Clubroom may close up to one hour early if there is insufficient business (4 or less patrons) and may keep Clubroom open past closing time.

- 6. Members will not reprimand any bartender or post officers in the clubroom. Complaints, suggestions and/or criticism should be deposited into the Suggestion Box or submitted in writing to the Clubroom manager or presented in person to the Clubroom Committee for resolution. After investigation of complaint(s) and review by the Clubroom Committee, the Clubroom manager will respond in writing to complaints within (10) ten business days. The use of the American Legion, Post 149, Clubroom, employees, members of the post or child organizations, as outlined in the Post 149 By-Laws, shall not be named, for the purposes of shaming or impugning or denigrating in any social media posting (i.e., Facebook, Instagram, or other types of social media) is prohibited.
- 7. Minors are not allowed to sit at the Inside or the Outside Bar at any time during business hours.

- **8.** Any person willfully damaging property or removing property from the premises shall be held liable for replacement of those items.
- 9. Post 149 members may cash checks up to \$25.00 at the bar. Any exceptions must be approved by the Clubroom manager. A \$25.00 service charge will be assessed for all returned checks.
- **10.** Members or guests who are obviously intoxicated will not be tolerated or served in the Clubroom, Patio or grounds. A bartender may call a taxi, Uber or Lift and the Clubroom will pay for the ride home.
- 11. No Alcoholic beverages will be served to any minor. No Member or guest will purchase or furnish alcoholic beverages to any minor on American Legion premises.
- **12.** No Alcoholic beverages will be removed from or brought into the Clubroom, Patio, or Post grounds.
- 13. Loud, profane, or any abusive language will not be tolerated. As a common courtesy to all guests present, loud, profane or any abusive language may be cause for the Bartender, Clubroom Manager, Clubroom Committee Member, or any Post Officer present to ask the patron to leave the premises.
- **14.** The Clubroom may be closed on some holidays. The closings will be posted in advance.
- 15. This is a non-smoking facility. Smoking area is on the patio or outside grounds.
- **16.** Patrons entering the clubroom will not enter through main hall when an event is in progress and posted at the main hall entrance.
  - a. Entrance to Clubroom in those instances can be made on the east side of the building.
- **17.** Clubroom door duty: Any person selected to do "clubroom door duty" should refrain from consumption of alcohol prior to doing Clubroom door duty.
  - **a.** Hours of duty will be 6:30 to 8:30 or as designated set by the clubroom manager.
  - **b.** No compensation will be paid.
- 18. Any patron bringing an un-registered service animal into the Clubroom area must keep the animal on a leash, keep them on the patio grassy area, and clean up after them. Registered service animals are exempt and may move about freely, however, must still be kept on a leash and clean up after them.
- 19. Bartender service area and priority The Bartender will service both the Inside Bar and the Outside Bar, priority given to the Bar area with most patrons at the time. Bartender must monitor both Bar areas at all times. Bartender is not a cocktail waitress and will not provide service to tables, inside or outside, unless time allows. Patrons will come to the Bar for service unless unable to do so because of disabilities.
